

# Caring Paws Pet Sitting Services, LLC

## Terms of Agreement for Pet Care

This signed document is an agreement between Caring Paws Pet Sitting Services, LLC, referred to as “Caring Paws” and \_\_\_\_\_, referred to as “Client”, for pet care services beginning on \_\_\_\_\_ until revoked in writing. Caring Paws agrees to provide pet care services to Client in a reliable, trustworthy, and caring manner.

1. Client authorizes Caring Paws to perform pet care services as outlined in Client Profile, Pet Profiles, Policies and Procedures, and Veterinary Treatment Authorization which shall become part of this contract.
2. Client authorizes Caring Paws to obtain any emergency veterinary care that may be necessary during the time spent with my pet. Client accepts responsibility for any charges related to this emergency care. Client also authorizes Caring Paws to utilize an alternative veterinarian in the event my primary veterinarian is unavailable. Every effort will be made to contact Client prior to obtaining emergency care.
3. Caring Paws accepts no responsibility for security of the premises or loss if other individuals have access to the home during the term of this agreement. Pet care will be performed only by Caring Paws during all assignments. Caring Paws does not 'share' pet care with client's family or friends.
4. Client agrees to reimburse Caring Paws for any additional fees for providing emergency care, as well as any expenses incurred for unexpected visits, transportation, housing, food, or supplies.
5. Caring Paws agrees to provide the services stated in this agreement in a reliable, caring and trustworthy manner. In consideration of these services and as an express condition thereof, Client expressly waives and relinquishes any and all claims against Caring Paws, its employees or assigns, except those arising from proven negligence of the pet sitter.
6. Caring Paws will not be liable for the injury, disappearance, death, or fines of any pet with unsupervised access to the outdoors.
7. Client will be responsible for all medical expenses and damages resulting from an injury to the pet sitter or other persons by the pet. Client agrees to indemnify and hold harmless Caring Paws in the event of a claim by any person injured by the pet.
8. Caring Paws reserves the right to terminate this contract at any time, at its sole discretion; likewise, Client may terminate this contract at any time. There is no term of contract for service.
9. It is expressly understood that Caring Paws shall not be held responsible for any damage to Client's property, or that of others, caused by Client's pets during the period in which they are in its care. Client has advised Caring Paws of all situations, which will relieve it of liability for damage.

10. Fees are earned upon acceptance of pet sitting reservations and are due on first day of service prior to pet care. Client must give a minimum of 24 hours notice to receive credit against future visits. If Client requests refund instead of credit, a one visit fee will be deducted for consultation costs IF only the initial get acquainted visit has taken place. A fee of \$35 will apply to all returned checks. Client is responsible for all costs of collections.

11. Client attests to the fact that all licenses and vaccinations required by the State of Texas, the City in which Client resides and/or the County of Harris are current according to the law.
